

ORDINANCE NO. 70

December 22, 1982

An agreement granting an exclusive franchise for a period of fifteen (15) years to H & H Cablevision, a partnership, for the construction, maintenance and operating of a community antenna system and lines of television coaxial cables, including poles, wires, and fixtures where necessary upon, along, through, and over and under streets, alleys, bridges and other public places of the City of Turrell, Crittenden County, Arkansas.

ORDINANCE NO. 84-1

April 17, 1984

An ordinance prohibiting the drinking of intoxicating liquors on the public streets or alleys or areas designated as public places in the City of Turrell, Arkansas.

ORDINANCE NO. 84-2

April 17, 1984

An Ordinance requiring premises to be kept free from weeds, grass, garbage, rubbish and other unsightly and unsanitary articles; requiring property owners to eliminate, fill up or remove stagnant pools of water or any other unsightly thing.

Nov. 15, 1979

An ordinance establishing Privilege Licenses for the operation of occupations and businesses in the City of Turrell, Arkansas (increase 1980)

RESOLUTION # 80-1

JAN. 17, 1980

Whereas, Cities and Towns in Arkansas have the right to determine the terms and conditions upon which a public utility may occupy the streets of the City or Town, including the amount and rate of the Municipal Franchise Tax.

RESOLUTION # 80-2

Feb. 21, 1980

That a tax of Five (5) mills on the dollar on the assessed valuation of all real and personal property within the city limits.

RESOLUTION # 80-3

April 17, 1980

The City Council of the City of Turrell, after a meeting in which the said Audit Reports were thoroughly discussed adopting the recommendations of the Legislative Joint Auditing committee and authorized by Jake Brick, City Attorney to advise the Legislative Joint Auditing Committee of the action taken pursuant to their recommendations.

ORDINANCE # 67

Aug. 20, 1981

An Ordinance prohibiting the possession, sale or use of any pyrotechnics, (fireworks) in the City of Turrell.

RESOLUTION # 81-1

Aug. 20, 1981

That a tax of Five (5) mills on the dollar on the assessed valuation of all real and personal property within the city limits.

ORDINANCE # 68

Aug. 20, 1981

An ordinance authorizing and permitting aldermen or members of the City Council of the City of Turrell to contract with or have an interest in a contract with the City furnishing supplies or equipment to the City.

ORDINANCE # 69

JAN. 21, 1982

An Ordinance amending Ord. #41 and Ord. #60 which provided for the fixing of rates for the Water and Sewer Systems for the City of Turrell.

RESOLUTION # 82-1

Nov. 15, 1982

That a tax of 1.6 mills upon the dollar for general purposes
That a tax of -0- mills upon the dollar for debt service

RESOLUTION NO. 76-1

Whereas, certain areas of the city of Turrell are subject to periodic flooding from streams and rivers, causing serious damages to properties within these areas; and whereas, relief is available in the form of Federally subsidized flood insurance as authorized by the National flood Insurance act of 1968.

ORDINANCE NO. 63

The owner of any land situated within the incorporated limits of the City of Turrell shall neither construct nor allow construction or placement, on such land, of any building structure without having obtained a building permit.

RESOLUTION NO. 76-2

Whereas, the City of Turrell has adopted and is enforcing Building Permit Ord. no. 63.

RESOLUTION NO. 76-3

That a tax of five (5) mills on the dollar on the assessed valuation of all real and personal property within the city limits.

ORDINANCE #64

An ordinance prohibiting the keeping of cows, horses, rabbits, pigs goats and domestic animals with the exception of dogs and cats.

RESOLUTION NO. 77-1

That a tax of five (5) mills on the dollar on the assessed valuation of all real and personal property within the city limits.

ORDINANCE #65

An Ordinance to fix the compensation of the elected officials of the City of Turrell. (to raise alderman to \$25.00 and Mayor to \$400.00)

RESOLUTION NO. 79-1

That a tax of Five (5) mills on the dollar on the assessed valuation of all real and personal property within the city limits.

RESOLUTION NO. 79-2

A Resolution authorizing the mayor of the City of Turrell to request State-Aid Street funds from the Director of Highway and Transportation

RESOLUTION NO. 79-3

A Resolution ratifies and confirms the previous practice of charging out of town water users the same rate as that effective for in town water users, plus the addition of \$1.00 to added to such out of town user for additional expence incurred by the City in servicing such.

RESOLUTION NO. 79-4

A Resolution that the city charge a 10% penalty on utility bills which were not paid prior to the due date indicated by the city.

ORDINANCE NO. 56

April 11, 1973

An ordinance limiting parking in the City Streets of the City of Turrell, Ark.

RESOLUTION NO. 57

That a tax of five mills on the dollar on the assessed valuation of all real and personal property within the corporate limits of the City of Turrell, Ark.

ORDINANCE NO. 58

May 31, 1974

An ordinance to provide that the office of City Marshall of the City of Turrell shall be filled by appointment rather than election and to fix the compensation for such office.

RESOLUTION NO. 59-A

October 10, 1974

That a tax of five mills on the dollar on the assessed valuation of all real and personal property within the corporated limits of the City of Turrell, be and the same hereby is levied and assessed for general purposes for the year 1974.

RESOLUTION NO. 59-B

April 10, 1975

Expressing appreciation to the 70th General Assembly for their accomplishments on behalf of the cities and towns of Ark.

ORDINANCE NO. 60

May 8, 1975

An ordinance amending sections 1 and 2 of ordinance no. 41 which provided for the fixing of rates for Water and Sewer System for the City of Turrell, Ark.

RESOLUTION NO. 61

September 11, 1975

That a tax of five mills on the dollar on the assessed valuation of all real and personal property within the corporate limits of the City of Turrell.

ORDINANCE NO. 62

March 18, 1976

An ordinance combining the offices of City Recorder and Treasurer in the City of Turrell, Ark.

Do not number Resolutions and Ordinances in the same order. From Resolution 61 to Resolution 76-1 are omitted.

Resolutions are now numbered by year and order in which they come . Starting with the year 1976.

ORDINANCE NO. 49

April 13, 1965

An ordinance authorizing the audit of city records and funds, including but not limited to waterworks and sewer systems, general revenue fund and all other city accounts by the office of the State Comptroller, City Audit Division, State of Ark.

ORDINANCE NO. 50

November 16, 1965

An ordinance granting the Ark. Power and Light Company, it's successors and assigns, the exclusive right, privilege and authority to sell, furnish and distribute electric power and energy and erect, maintain, extend and operate a system for the distribution, transmission, furnishing or sale of electric power and energy to the City of Turrell, Ark.

ORDINANCE NO. 51

April 15, 1969

An ordinance to fix the compensation of the elected officials of Turrell, Ark.

RESOLUTION NO. 51-A

October 13, 1970

That a tax of five mills on the dollar on the assessed valuation of all real and personal property within the corporate limits of the City of Turrell, Ark.

ORDINANCE NO. 52

July 14, 1971

The licensing of all dogs within the corporate limits of the city of Turrell to regulate and limit dogs from running at large within the corporate limits of Turrell, Ark.

ORDINANCE NO. 53

September 8, 1971

An ordinance to authorize the City of Turrell to join in area planning and become a member of a regional planning commission.

Resolution No. 54

That a tax of five mills on the dollar on the assessed valuation of all real and personal property within the corporate limits of the City of Turrell, Ark.

RESOLUTION NO. 55

January 1, 1972

That the City of Turrell pay such expenses incurred by the Mayor by City check up to the sum of \$50.00 per month upon presentation of an itemized bill or statement.

ORDINANCE NO. 40

February 6, 1962

An ordinance submitting to the voters of the city of Turrell, Ark., the question whether it will issue bonds to the extent of \$17,500 for the purpose of aiding the construction and installation of a sanitary sewer system for the inhabitants of the city of Turrell and bonds to the extent of \$17,500.00 for the purpose of aiding the construction and installation of a waterworks system for the city of Turrell, Ark.

ORDINANCE NO. 41

May 21, 1962

An ordinance fixing rates for water to be furnished by the waterworks system and for services to be furnished by the sewer system of the city of Turrell, Ark.

ORDINANCE NO. 42

September 4, 1962

An ordinance amending section 1., of ordinance no. 41 fixing rates for water to be furnished by the waterworks system in the city of Turrell, Ark.

ORDINANCE NO. 44

An ordinance providing for the issuance of General Obligation Bonds of the city of Turrell, Ark. for aiding in the construction of a sewer system and a waterworks system to serve the city.

ORDINANCE NO. 45

April 12, 1964

An ordinance regulating and fixing the maximum speed for the operation of railroad trains through the corporate limits of the City of Turrell, Ark.

ORDINANCE NO. 46

May 12, 1964

An ordinance providing for the issuance of General Obligation Bonds of the city of Turrell, Ark. for aiding in the construction of a sewer system and a waterworks system to serve the city.

ORDINANCE NO. 47

May 12, 1964

An ordinance providing for the issuance of Waterworks and Sewer System Revenue Bonds to aid in the construction of the waterworks and sewer systems to serve the city.

ORDINANCE NO. 48

November 13, 1964

Failure to connect to and begin using the sewer system prior to March 15, 1965, may subject you to penalty provided by ordinance, not to exceed \$10.00 per day with each day's violation being a separate violation.

ORDINANCE NO. 30

March 12, 1956

An ordinance to levy an annual occupation tax upon all persons, carrying on a business.

ORDINANCE NO. 31

April 9, 1956

Providing for the prior payment of gas transmission and distribution system revenue construction bonds of the town of Turrell.

ORDINANCE NO. 32

July 9, 1956

An ordinance amending section 3, ordinance no. 8, which provided for the construction and operation of a water works system for the incorporated town of Turrell, Ark.

ORDINANCE NO. 33

June 9, 1956

Requiring that all cotton gins, cotton ginning plants and other plants and factories from which dust, trash and lint arises, be equipped with suitable and efficient means to prevent the escape of such dust, trash, and lint from the premises thereof.

ORDINANCE NO. 34

September 10, 1956

To enter into an agreement with the State of Arkansas to obtain insurance coverage for the employees of the City under the provisions of the Federal Social Security Act.

ORDINANCE NO. 37

May 13, 1958

An ordinance creating and establishing a Civil Defense Agency

ORDINANCE NO. 38

September 9, 1959

An ordinance fixing and establishing the aggregate amount of license fees, charges and special taxes due Turrell from the Mid South Gas Co.

ORDINANCE NO. 39

September 8, 1959

An ordinance raising the classification of the incorporated town of Turrell, Ark. from an incorporated town to a city of the second class and providing that the officers of said incorporated town shall become officers of a city of the second class to serve as such until their successors are elected and qualified.

ORDINANCE NO. 16

January 6, 1948

An ordinance to levy an annual occupation tax upon all persons, firms, partnerships, associations and corporations engaged in carrying on or following certain trades, business, professions, vocations and/or callings within the corporate limits of the town of Turrell and to provide the time for payments of such occupational and/or privilege taxes and to provide penalties for non-payment thereof.

ORDINANCE NO. 17

August 15, 1956

An ordinance to the Incorporated Town of Turrell, Ark. provides that it is unlawful for any person, persons, partnership, association or corporation to dump, place or leave trash or debris of any kind along any highway through the Town of Turrell or on any street or alley.

ORDINANCE NO. 19

September 12, 1949

An ordinance to regulate the sanitary conditions in the Town of Turrell, Ark.

ORDINANCE NO. 20

May 30, 1951

The period of time which Midsouth Gas Company as assignee, may begin the laying of pipelines and materials for the distribution of Natural Gas in said town and for other purposes.

ORDINANCE NO. 21

June 6, 1950

An Ordinance of the town of Turrell fixing a schedule of rates for Natural gas service.

Ordinance No. 24

April 1954

An ordinance authorizing the leasing of the proposed natural gas distribution system and its related facilities of the Town of Turrell, Ark. and the execution of the agreement and lease, with an option to the Lessee to purchase.

ORDINANCE NO. 28

An ordinance authorizing the leasing of the proposed Natural Gas Distribution system and its related facilities of the Town of Turrell, Ark. and the execution of the agreement and lease, with an option to the lessee to purchase.

ORDINANCE NO. 29

March 1956

An ordinance amending section 3, ordinance no. 8, which provided for the construction and operation of the water works system for the incorporated town of Turrell, Ark.
